7:00 PM – Meeting Called to order by Mr. Ackland.

7:06 PM – Discussion on PC/SB Joint Meeting for October 24, 2017 – Town Plan

Mr. Ackland started the discussion off by commenting "Where is the Town going in the future." Mr. Ackland commented that there are parts that fall within the Selectboard. In the end, the Selectboard approves the working document. The meeting will have the Consultant there to explain and answer any questions about how the Town Plan will be presented. Mr. Ackland commented that it should be a working, living, usable plan that is readable and not as complicated as the one we have currently. Mr. Graves commented that she will have compiled the survey data with the subjective comments that were written in. There were three things that Mr. Graves commented that area's that needed work. 1) was to condense and make it less of a novel, 2) Change the Power/Energy section with the new PSB regulations and where does the town go from there. 3) Ridge Line Development/Forest Line defragmentation planning. One comment was possibly adding limitations on square footage of homes that can be built. The Town Garage site was initially to be planned to free up the property, moving the town garage to another location to increase the density within the Village Area. The Sugarbush Fire Station Committee with Sugarbush having discussions on tearing down the old station and building it bigger and longer, but there are wetlands to be considered.
