7:00 PM – Meeting called to order by Mr. Cunningham.

7:05 PM – Public Comment – Mr. Campanelli asked about the Department of Public Works Position and if there was a job description since the salary in the Town Report was at \$35, 000 and in future years \$70,000. Mr. Cunningham commented that it is in the process of being developed. Mr. Campanelli wanted more information on why this position was needed. Mr. Cunningham commented that the board sees future Capital Town wide projects that would need to have more managerial oversite such as the Town Garage and the Warren Covered Bridge. Mr. Cunningham did comment that there would be information available in the next two weeks regarding this position.

7:10 PM – Warren Library – Moving Forward - Ms. Schmukal and Ms. Kucera came to the board to talk about a series of community public outreach meetings they are doing to see what the aspirations of the community might be and how they fit into the library. Ms. Schmukal commented that they are working on a strategic plan that will be good for 3-5 years. Mr. Ackland commented that they should talk to the Mad River Planning District that has done a lot of studies to see what the community's aspirations are in area's as there is some good data available. Ms. Schmukal commented that they are working on trying to see how the Library's role fits into the process. They have reached out to targeted focus groups such as the PTO, The Community Fund, Warren Church, Valley Rotary, children's play groups etc. They are just in the information gathering stage at this time. M. Ackland suggested that they reach out to the Planning Commission as they have a lot of good work that has been done on the Town Plan that has gathered data on the community's aspirations as well. Ms. Schmukal and Ms. Kucera thanked the board for their suggestions and comments.
