9:00 AM – Public Comment – None

9:05 AM – Setting the Municipal Tax Rate – Ms. Jones presented the calculation worksheet of 0.415 on a Grand List of \$7,367, 920.06. Mr. Cunningham entertained an idea of rounding the rate down to 0.410 cents since the board has cut cost spending of non-essential spending items. Mr. Ackland and Mr. Youmell both agreed that would a good idea.

Motion by Mr. Ackland to authorized a tax rate of .041 cents, second by Mr. Youmell. All in Favor:
VOTE: 3-0.

At this time Ms. Lisaius commented that the state is still calculating the homestead rates. Ms. Lisaius commented that she has seen that the Non-Residential rate will be \$1.628
