6:00 PM – Public Comment – None

6:05 PM – COVID-19 Update – Jeff Campbell-There are 3,762 Total Cases. Cases statewide in the last 14 days: 1,300. Currently Hospitalized: 22 with 5 in ICU. Positive Cases in Washington Country in the last 14 days: 394. Deaths: 64 with 5 in the last 14 days. Total people tested: 216,701. Total Tests: 527,945. Tested in the last 14 days: 80,364 compared to 9,164 the prior two weeks.

Numbers of Concern: NY has 602,000 cases an increase of 70,000. MA has 208,000 cases and increase of 36,000. NH has 18,000 cases an increase of 5,300. Maine has 10,800 cases an increase of 2,800.

Cases: During the past two weeks we have had 11 days with cases over 81, 70 being the highest case total before 11/11/20. Our highest case daily case total was 150, which occurred on 11/18/20. Current cases count in the area as of 11/18/20: Warren = 8 Waitsfield = 9 Moretown = Less than 5 Fayston = 0 Waterbury =31.

Update on testing expansion initiatives:

The State is also testing aggressively. In the last 7 days, there's been a 40% increase of testing in Vermont. The Department of Health is working with the private firm CIC Health to enhance and expand testing capacity. We want to provide asymptomatic testing within a 30-minute drive of every Vermonter. Five new fixed testing sites opened this week and the State will work on more sites and more testing slots per site. The State is partnering with hospitals, healthcare centers and EMS agencies in this effort. This increase in testing will not be enough to satisfy the huge demand. The State will continue to increase testing opportunities until demand is met. We've also started surveillance testing of all teachers/ school staff, with the goad to test all who want it this week, then testing a quarter of schools each week. Testing is being offered almost daily in Barre, Northfield, Waterbury and Middlebury.

Coop Planning Update:

Coop plans is still in the works hoping to have the next version done by next week. The recommendations that were suggested to both the Town and Library are being implemented and as far as Jeff's knows are going well. I will be working with Andrew from the Highway Department to see about a MOU with other Valley Towns in case of an outbreak within t he Valley. This may be a challenge, but somethings should be in place.

6:15 PM – Traffic Ordinance Change Plunkton Road – Mike Malekoff – Mr. Malekoff started off the conversation that he had spoken with several residents concerning this issue. He found that it was a mixed reaction to lowering the speed. The data received showed that there was speeding but lowering the speed does not mean that people will abide by the speed limit. The main point was that the Traffic Ordinance needs to be ratified for the correct speeds on the road, so that there could be enforcement for tickets. He stated that Blueberry Lake was very busy this year with all the parking lots full, cars parking on the road and people walking to the lake for recreation. The temporary speed signs have slowed traffic up as they approach the lake area. Mr. Malekoff also asked why are their lots of large trucks using the road and could we limit that? Mr. Cunningham commented that the Town could not really limit truck use of that road because this road connects town to town and many commuters use it. Mr. Hoare commented that he appreciates Mr. Malakoff's efforts but did not think there was a large speeding problem. Many people are happy with the road improvements that have been done and it is a recreational area with increased traffic because of covid. He commented that the speed limits are fine as long as there is enforcement and was in favor of leaving the current speed limits in place. Mr. Cunningham commented that he felt the current speed limits are fine but the ordinance needed to be corrected for enforcement. In the spring/summer of 2021 more data will be taken and a plan for enforcement would be discussed.

Motion by Mr. Cunningham from Brook Road to Jones Road, on Plunkton Road would remain 40 MPH, and from Jones Road to the Granville Town Line the posted speed would be 35 MPH, second by Ms. Behn. All in Favor: VOTE: 5-0.

6:31 PM – Pike Response – A letter that came from the Warren Selectboard was sent out to Pike Paving in regards to the hold back. In conversations with Mr. Gardner it was noted that he understood that they knew that the Warren Selectboard were not happy with the job that the Town received. Mr. Gardner's boss, Chris Jarvis, felt that the job and solution was acceptable.

Mr. Jarvis has not responded to the latest letter the Selectboard sent in regards to the hold back of \$18,000. Mr. Gardner understood where the Town was coming and from where his boss Pike were coming from and hoped that a reasonable solution would become of it. This issue is still not resolved and the Town is waiting for Pike keeping the lines of communication open. Mr. Cunningham commented are there any possibly solutions? Mr. Ackland commented that there really isn't any. It would be pretty costly to go to court and that is not what the Town wants to do. Mr. Ackland commented that he would be ok paying the hold back however, a more definite plan of how Pike will work in the future with the Town, making sure the mix is correct and that they come on a timely basis's and not push the town off until late September and October. Mr. Graves commented that is not happy with the work and thanked Mr. Ackland for writing the letter and that Pike does owe the Town a response. Ms. Behn also commented that she felt the same way that the paving job was not up to professional standards. Mr. Youmell commented that nothing would be voted on at this meeting until a response is received from Pike Industries.

6:51 PM – Lighted Visitor Covid Information Signs – Sugarbush – Margo Wade and Jim Westhill. Ms. Wade and Mr. Westhill came before the board to ask permission to have 2 large highway lighted signs for the duration of the 2020-21 Ski Season (December-March) because of the States guidelines. They looked at sign placements along the Access Road so that they would flash and be a nescience to people living in the condos. Sign Placement Locations are as follows:

1. Base of Mt. Ellen Road, Fayston (south side of road), 1870 Sugarbush Access Road, Warren (north side of road adjacent to Sugarbush Inn Annex), 3. Adjacent to Golf Course Road (north side of Access Road), 4. Adjacent to Parking Lot E (north or south side of Access Rd) and 5. Other resort owned locations with notification provided to the Selectboard. They are planning on renting 2 of them putting one at Mt. Ellen and one at Lincoln Peak and are requesting the flexibility to deploy both at one mountain should the need arise. The sign dimensions are as follows: sign face 6'3" × 11'6", sign height is 13' 3" with the sign lettering configuration of 3 lines of 8 characters (max) per line. The messages would be mostly COVID-19 but with general messages s as well. Mr. Westhill commented that they are working with the State and CDC requirements hitting the people early before they get to the mountain. Upon arriving they will have to wear masks and bring activavids saying they have quarantined. Ms. Behn commented she would only like to see Covid messages and not a lot of general messages. Mr. Westhill commented that they are not using these signs a COVID-19 point of advertising.

Mr. Cunningham asked how will it work with pass holders? Mr. Westhill commented that pass holders will have to go on line and fill out the actividavide stating they have self-quarantine at home to meet the state requirements. If they do not go on line prior to going to the mountain, their passes will not work. At both mountains there will be a limit of 6000-7000 operating at the capacity allotted. They also will be selling some pre-sold tickets. He commented that it would be best for locals to ski from Monday-Friday. Mr. Cunningham commented that this signage is only a onetime event due to Covid and that they would not want it flashing all night into people's windows. Mr. Westervelt commented that is why they picked the sites for location and that it is on Sugarbush property. If it became a nauseous to someone, they would remove them to another location. Mr. Graves commented that the PC wanted to make sure it was just temporary and that they would be gone in March. Mr. Westervelt addressed that question as it is only for the 20-2021 ski season.

Motion by Mr. Ackland to grant approval for Sugarbush the use of the signs for the 20-2021 ski season relate to covid, second by Mr. Youmell. All in Favor: Vote: 5-0.

Camping – Another topic that Sugarbush wanted to bring up to get an idea from the Selectboard was camping in the lots. They have had requests for overnight camping in their lots of people using their own vehicles to camp in the base lodge parking area. Mr. Westhill commented that we are not open to parking large vehicles such as vehicles with travel trailers. If they did, there would be no fires, no septic, dogs on leash, pack in pack out and the best place to do this would be in Lot G. If they ever did, it would be on the Heli Lot and there would be only 1-15 sites with septic, however, they wanted to get Selectboard feedback on this. Mr. Cunningham commented that it would be creating a community of gathering of people and this is not what the Governor wants currently.

Mr. Graves commented that Ms. Robbins sent over the Zoning Regulations on this and camping is not allowed only in an established camp ground. He did suggest that Sugarbush come to the Planning Commission and express their comments on this topic in quite detail. this. Ms. Wade commented that they are coming to the next meeting with comments on new re-write of the zoning regulations.

7:96 PM - Roots Work Check In – John Barkhausen & Don Swain – Mr. Barkhausen started off the with updating the board with building improvements over the years. This past summer the board hired Hugh Johnson to replace siding on the south and east side of the building fixing the rot by the metal fire escape. In 2021 they plan on painting the building. The cost for fixing the rot repair was \$5,200 and they spent \$4,200 on the sewer repair. In 2019 they had spent \$3,000 in repairs, in 2018 they spent \$18,000 which was part of the window replacements and also in 2017 \$17,000 for phase one of the windows. They added an electric heater in the crawl space and have done some electrical upgrades to the rooms upstairs and replaced some doors. They also had renovated the front porch entrance to the building over the years. The Market has renovated the bathroom twice. Roots Work also takes care of the green mowing and various gardens. Mr. Ackland asked how does Roots Work pay for this work? Mr. Swain commented that they have a reserve fund for emergency work which is funded through the heating program.

They are also planning on doing a Capital Improvement Plan identifying the remaining life of items of the building and set up a budget for 5-10 years on repairs. When they have put together a schedule t Roots Work will share this with the board and discuss where the Town might be able to help out. Mr. Cunningham commented that Roots Work has done a remarkable job in the stewardship of this building and property and thanked the members of the board.

7:25 PM – Other Business:

Paying the EMD – Mr. Cunningham brought up the discussion on whether to pay Mr. Campbell for his time and efforts with Covid. There is a grant that covers most of the time already put into this position as Ms. Jones had figured the 406 hours into the grant request previously at \$12/hour. Some board members felt that the \$12/hr. was not enough and should be more, however, Ms. Jones had taken the Fire Dept number to apply for the time. At this time the board will stick with the \$12/hr. but in the future will look at this rate.

Motion by Mr. Cunningham to pay Mr. Campbell \$12 hour for the 406 hours of time spent on COVID-19 and submit expense to the grant, second by Mr. Youmell. All in Favor: VOTE: 5-0.



Update on outbreaks and clusters


- There are currently still a number of outbreaks stemming from both the hockey tournament as well as a number of Halloween Parties
- There are currently 24 outbreaks and 163 situations in the state, 51 of which are in Washington and Orange counties.
- 71% of situations and outbreaks are related to private parties and gatherings. This means that viral
 growth in Vermont is currently being fueled less by interactions at schools, restaurants, gyms, etc., and
 more by social gatherings.

Cross-State Travel

- All of Northeast is Red except Aroostook County in Maine which is Green
- The state has stated posting COVID-19 signage on all state roads and off ramps
- Signage for Roxbury Mountain is in the works

Estimated Active Cases per Million in VT Region

This regional map is for informational purposes only. It illustrates the estimated active cases per million across the Northeast and categorizes counties into **green**, yellow, or **red** based on their estimated active case counts.
