The PC selected the following roads to recommend to the Selectboard for Scenic Road Designation:

- Roxbury Mountain Road
- Lincoln Gap Road
- Airport Road
- Fuller Hill Road
- Main Street
- Golf Course Road
- West Hill Road

- East Warren Road
- Dump Road
- Senor Road

The PC selected these roads based on the score they received during the study, prioritizing roads that are throughways. Ms. Hill will write a memo to the Selectboard and get on their agenda to discuss the recommended roads.
